  - VoIP phone systems in daily use
  - Multiple computers and cloud-based business applications
  - Frequent video conferencing and online collaboration
  - General business internet usage across departments
2. SCTIE is experiencing limitations with our current connection and would like recommendations for a business-grade fibre package that can reliably support:
  - Stable VoIP call quality with low latency and minimal jitter
  - Consistent upload and download performance during peak usage
  - Multiple simultaneous users without network congestion
  - Guaranteed reliability and uptime for business operations
3. Service providers are to also advise on:
  - Recommended bandwidth for our usage profile
  - Symmetrical fibre options (if available)
  - SLA/business support options
  - Failover or backup connectivity recommendations
